

 PUWER, like LOLER and Management of Health and Safety at Work Regulations 1999 are designed to work
alongside the HaSaW (etc) A 1974 where employer's and employee's duties remain unchanged.

- Work at Height Regs 2005
- MHSaW Regs 1999
- PPE Regs (amended) 2022



MEWPS FITTED WITH EXTENSION DECKS

TOOLBOX TALK

Mobile Elevating Work Platforms (MEWPs) Category 3a (e.g., scissor lifts) are sometimes fitted with extension decks, these can be single, or double deck extensions. The purpose of an extension deck is to provide additional horizontal outreach beyond the main deck of the platform.



WHO NEEDS TO KNOW?

This Toolbox Talk applies to all individuals involved

- with the safe use of a MEWP, including: → Users/hirers
- → Managers and supervisors
- → Operators
- → Nominated ground control rescue persons

HOW DO YOU REDUCE THE RISK?

- → The Rescue Plan should consider the recovery of a MEWP if the deck is extended over a structure
- → Where possible retract any extended deck(s) before lowering the platform or driving the MEWP
- → Never exceed the maximum safe working load (people, tools and equipment) allowed on the extension deck. This information can be found on the extension deck decal and in the MEWP operators








